[redacted] was interviewed at her residence. After being advised of the identity of the interviewing agents and the purpose of the interview, the following information was provided:

KEMMERER identified her mother as HILDAGARDE "HILDA" MARCIN MARCIN, who was a passenger aboard UNITED AIRLINES Flight 93 on September 11, 2001. She provided her mother's date of birth as December 11, 1921, and place of birth as Schwadelbach, Germany.

MARCIN had retired in June of 2001 from the Mount Olive Township School Department where she was employed as a special education instructional aide. KEMMERER confirmed that MARCIN lived at 10-1B Scenic Drive, Budd Lake, New Jersey, prior to moving in with KEMMERER in June of 2001.

MARCIN was aboard Flight 93, traveling to her daughter's residence to establish a permanent residency in California. MARCIN's daughter CAROL O'HARE purchased the ticket for her mother in March 2001.

KEMMERER's last contact with her mother was upon dropping MARCIN off at Newark Airport for her flight on the morning of September 11, 2001. She had no unusual conversations with MARCIN on their drive to Newark. MARCIN had four pieces of luggage, two which she checked and two she carried onboard. KEMMERER requested that if any personal effects belonging to her mother are recovered, they be return to her. DNA samples have already been provided to the appropriate authorities.

KEMMERER was advised of the Victim/Witness Assistance Program. KEMMERER was provided a Victim/Witness Assistance Program brochure, as well as a business card, with the names of the interviewing agents.
