They did not present evidence of MOHAND ALSHEHRI having officially stayed at the motel. In a separate interview with FBI agents, however, motel guest [redacted] positively identified MOHAND ALSHEHRI as having stayed at the Crystal Cay Motel (although [redacted] could not be specific on the dates). These two separate interviews strongly suggest that MOHAND ALSHEHRI spent some time at the Crystal Cay Motel during the time period of 7/26/01 to 8/2/01.

He was accompanied by AHMED ALNAMI (UA Flight #93 hijacker). The name listed on the account was MOHAND MF AL SHEHRI. Also on 6/01/01, he was issued a SunTrust VISA debit card (# 4011 8060 7081 5823), which he could use to make withdrawals from his account.

On 7/07/01, MOHAND ALSHEHRI used this same SunTrust VISA debit card (# 4011 8060 7081 5823) at a Kinko's store at 2501 North Federal Highway, Boca Raton, FL.

On 7/06/01, he made another deposit of \$1,700.00. During this transaction, he was accompanied by HAMZA ALGHAMDI (UA Flight #175 hijacker).

On 9/5/01- only six days before the attack on the World Trade Center - MOHAND ALSHEHRI withdrew \$6,400.00 from the account, via a check presented at the SunTrust branch. During this transaction, he was accompanied by HAMZA ALGHAMDI (UA Flight #175 hijacker) and MOHAMED ATTA (AA Flight #11 hijacker). As of 9/11/01, only \$81.78 remained in this account.
