When SMITH visited the site of the UA Flight 93 crash in Pennsylvania last week, she was contacted by Special Agents of the Federal Bureau of Investigation FBI. SMITH advised that she was interviewed by the said agents and provided personal and background information regarding her daughter, <u>WANDA GREEN</u>. SMITH advised that the FBI also made arrangements to obtain her blood sample for the purpose of DNA comparison to recover the remains of her daugther. SMITH then provided the FBI with her blood sample.
